#### **MINIMUM QUALIFICATIONS**

- Excellent piano skills with ability to play accurately with attention to detail.
- Proficient in reading and preparing intermediate and advanced-level choral music.
- Ability to isolate specific choral parts when requested.
- Ability to simultaneously play multiple vocal parts from an open or closed-score choral work.
- Ability to successfully sight read repertoire during the early stages of rehearsal on a new work.
- Ability to identify pitch and rhythm mistakes in individual vocal parts during rehearsals or sectionals.
- Ability to play multiple genres, styles, and read various types of notation (i.e., chord symbols, lead sheets, etc.).
- Ability to offer constructive feedback focused on promoting students' musical growth.
- Positive, patient, and energetic personality with a readiness to connect with students and navigate challenges in the choral music classroom.



Good communication skills, both oral and written.

## **ESSENTIAL FUNCTIONS**

- Accompany choirs on a daily basis, rotating throughout the week between Lakeland High School, Muir, White Lake, and Oak Valley Middle Schools (only one school per day). Daily rehearsals will occur mostly during the morning.
- Accompany any additional rehearsals that may occur after school or in the evening (scheduled in collaboration with the accompanist).
- Accompany each school's choir at concerts and dress rehearsals throughout the year, plus Choral Festival and Solo & Ensemble performances with ensembles and individuals.
- Lead sectional rehearsals as needed by playing parts, identifying student mistakes/problem areas, helping correct errors, and providing constructive feedback to students.
- Develop positive relationships with the students, providing them with an additional positive musical mentor in the vocal music classroom.

**EDUCATION and/or EXPERIENCE**: High school diploma in addition to extensive private or college-level training in piano, private voice and/or choral music; experience of at least two years as an accompanist and/or experience choral music performance.

**MATHEMATICAL AND REASONING SKILLS:** Ability to speak and write effectively. Ability to apply mathematical concepts to practical situations. Ability to carry out instructions furnished in written or oral format and deal with problems involving several concrete variables in standardized situations.
